#### LTEA BACKGROUND

- LTEA was established 27 years ago as a "friendly society" under Lesotho's Friendly Societies Act
- In 2002, then registered with Lesotho's Registrar of Trade Unions and Employer Associations as an Employers association
  *"The voice of the Lesotho Textile & Apparel Industry"*

### LESSON AND INSIGHTS ON THE AGOA TEXTILES AND APPAREL STRATEGY INSIGHTS FROM A LESOTHO-BASED EXPORT FIRMS UNDER LTEA

Lesotho as a Least Developed Country (LDC) is eligible for a number of preferential trade agreements including USA preferential market access under the Africa Growth Opportunities Act (AGOA).

#### Con.

- The sector is the second largest employer after public sector
- The largest SACU exporter of textile and garments to USA.
- Also the second after Kenya in Sub-Saharan exporters to USA.
- There was a shift in the market due to the spread of COVID-19.
- Essential products such as PPE have become more important than fashion items
- Will Lesotho remain competitive or what?

# The Lessons and insights on the AGOA for Lesotho

- The second largest employed workforce of about 50 000 of which 80% is women
- Contribution of 2.6% to Lesotho's GDP on the third quarter of 2019
- Capacity to US market knowledge/ know how
- Capacity to produce about 90 000 dozens per month (960 000 pieces of garments)
- Accreditation of WRAP certifications
- Capacity for maintaining quality and standard by having Audits (different from WRAP) per each order

# The Lessons and insights on the AGOA for Lesotho. Cont.

- Strengthening of Regional and International Competitiveness capacitating the reduction of cost and standing blocks affecting Textile & Apparel sector through public private trade facilitation bodies
- Strong collaboration and support from Government agencies in particular LNDC in trade and investment facilitation
- The Pre-arrival process of release and clearance of Goods electronically for both Exports and Imports

# The Lessons and insights on the AGOA for Lesotho. Cont.

- Improved border infrastructure to ensure more efficient border crossing
- Removal of Goods in Bond (RIB) the movement of goods by the Exporting and Importing Agent in Lesotho liaising with other Agent in South Africa from the factories gate to the port
- The Forwarder an Agent nominated by the Buyers in US who's responsible for the movement of goods from the Port to US (destination)

### Ownership, Control & Decision Making in Lesotho's Textile, Apparel & Footwear Sector

There is a combination of investors in Lesotho from Lesotho (small factories), South African (medium to large factories), and Taiwan (large factories) serving different markets including USA.
